Successes to Date

- Montgomery Parks and Planning Open Parkways: Worked with Parks and Planning staff to help support open parkways (Sligo, Beach) during COVID-19
- Montgomery County Department of Transportation "Shared Streets" Program: Worked to MCDOT to support "streateries," implementation of neighborhood greenways, and implementation of new streamlined permitting process for neighborhood shared streets projects.
- Maryland State Highway Administration, University Blvd Bike Lane Pilot: Supported SHA in the development of a project plan for over 1 mile of protected bike lane along University Ave in Wheaton coming June 2021.

Residents have asked for a safer way to walk and ride bikes in Wheaton, and the State Highway Administration has agreed to make one lane in each direction for bikes ONLY.

University Blvd. Project:

- Allows safety for bikes and pedestrians, by creating a buffer
- Provides connectivity between Sligo Parkway, neighborhoods, Wheaton Central Business District, and transit.
- Includes data collection, as part of a FHWA research grant.



What's Next?

- Continued work throughout the COVID-19 Pandemic
 - Monitoring results of the SHA bike lane pilots, gathering support for similar projects along other corridors
 - Continued work with MCDOT on the evolution of their Shared Streets projects
 - Continued advocacy for additional Open Streets concepts and opportunities
- Work *beyond* the COVID-19 Pandemic
 - Principles are extremely vital during COVID-19, but there is continued need to develop these solutions beyond the pandemic
 - We have a long-term vision to continue building community, connectivity, and equity on a multitude of upcoming projects
